GREEN INITIATIVES ON THE HORIZON

Effective January 1, 2024, new plastic bag/paper bag legislation will take effect throughout the region in Prince George's County, Anne Arundel County, Greenbelt, and City of Laurel.

On January 1, 2024, a retail establishment shall charge, collect and retain at least ten cents (\$.10) for each paper carryout bag that it provides to a customer. Here are the highlights for the City of Laurel's own Ordinance:

- A retail establishment shall post notices that advise customers to bring reusable bags and that a paper bag will be subject to a fee.
- The notices shall be posted at the public entrance to the retail establishment and at each point of sale and shall be in English and Spanish.
- The fee charged shall be paid by the customer and retained by the retail establishment.
- The sales receipt shall reflect both the number of bags provided to the customer and the fee collected for the bags.

Following the rollout, residents will be able to report non-compliant stores through online reporting or a hot line. So, avoid the fee and bring your own bag!

Residents may not get plastic bags at checkout, but that doesn't mean that there isn't plastic film to be recycled. Residents can bring all plastic film to the City's new drop-off containers. The containers are located at Joseph R. Robison Laurel Municipal Center (8103 Sandy Spring Road), the Robert J. DiPietro Community Center (7901 Cypress Street), the Laurel Armoy (422 Montgomery Street) and the Laurel Police Department (811 5th Street).



Laurel Division of Emergency Management: BEING PREPARED FOR WINTER TRAVEL

The weather has a habit of changing quickly, especially during the winter. With forecasters predicting a higher than average amount of snow for this season, now is the time to prepare yourself for winter travel.

As we have learned from past experiences, powerful winter storms can bring considerable amount of snow, ice, and strong winds, creating whiteout conditions. Temperatures can drop 50 degrees or more in only a few hours. These hazards can occur with little to no warning! Educate yourself now about how to travel in hazardous winter conditions and how to be prepared.

Following are just a few tips on preparing for winter road travel:

- Check Road Conditions Along Your Route:** Weather conditions can change quickly when traveling, check the hourly conditions at your local National Weather Service Office.
- Have A Winter Weather Emergency Kit Ready:** Your kit should include items such as jumper cables, flares/reflective triangles, ice scrapers, cell phone chargers, blankets, a map, tire chains or sand.
- Winterize Your Vehicle:** Keep your vehicle in tip top shape to tackle the winter weather by switching to winter tires, installing winter wipers, and keeping your gas tank above half full.
- Stay Connected:** Using your mobile phone, you can receive the most up-to-date weather warnings from the National Weather Service.
