



## WEB SITE REVAMP HAS BEEN LAUNCHED!

The City of Laurel Department of Information Technology continues to work diligently with other City Departments to make sure that the City's web site at [www.cityoflaurel.org](http://www.cityoflaurel.org) houses the most accurate and comprehensive information about City programs, resources, and services possible.

In November, we launched a new web site and mobile app with a more comprehensive search, better support for accessibility standards, and newly organized content. While we're proud of this result, there is plenty more work to be done, and we'd love to hear your feedback on the changes!

### What You'll Find:

- When important alerts need to be shared with the public, they are visible in an alert bar across the top of every page on the City web site.
- News and Events are shared on the City home page, as well as under the News Center and the Calendar.

- Information about Boards and Committees, including their upcoming meetings, agendas, and past meetings minutes, are available under the Government menu!
- Search is improved with autosuggest, better indexing, and a prominent new location in the page header, allowing you to find your way around the site via keywords or the menus, whatever fits you best!

The new MyLaurel Maryland mobile app for iOS and Android is fully integrated into the web site as well, with news, calendars, and other information that can be pushed right to your fingertips in the app. Get it at [cityoflaurel.org/mylaurel](http://cityoflaurel.org/mylaurel)! The app still has the ability to report issues and submit requests to the City. Please note that if you were a MyLaurel MD user previously, you will need to download the new app, and you can safely remove the old one.

**Get Notified!** You can register to receive specific types of notifications, by category, about new press releases, alerts, events, and projects, both in the mobile app and the web site! You can specify whether you'd like to receive your notifications via email, mobile app notification, or both!

## READY FOR WINTER? LOOKING FORWARD TO SPRING!

Public Works has already been hard at work this winter, making Laurel's roads safe for travelers. Below are their guidelines for preparing for winter weather and what is coming up this spring!

### Brining, Plowing and Salting

Before a winter storm, the Department of Public Works pre-treats priority 1 and 2 roads with a brine solution, a new tool implemented just this season, which helps mitigate snow and ice build up if used to treat within 48 hours. The Brine Operations System, purchased through ARPA funds, was setup and Public Works installed a 6,100-gallon fiberglass tank in the DPW yard to store brine that is produced onsite, and several DPW vehicles were retrofitted to deploy the brine during snow events.



During snow removal, emphasis is placed on Snow Emergency Routes, high-priority streets, and hazardous locations such as hills, sharp curves, and busy intersections. Once these high priority areas have been treated and cleared of snow, side streets are treated.



Snow removal can be a monumental task, so we ask residents for patience. City crews work around the clock to clear streets and maintain regular services. While efforts are made to avoid blocking driveways when plowing, it cannot always be avoided. When clearing driveways, please do not shovel snow back into the street.

### When is a Snow Emergency in Effect?

The City's Snow Emergency Plan goes into effect whenever a Snow Emergency is declared for Prince George's County. The Mayor may also proclaim or end a Snow Emergency.

Snow Emergencies are announced on most local radio and television stations, as well as on the City's social media sites. When a snow emergency is in effect, residents cannot park on the even-numbered side of snow emergency routes.

### Coming This Spring!


The Department of Public Works will be hosting the April Recycling event on

Saturday, April 20, 2024, from 8:00am to Noon. This event is for City residents only.

Public Works will provide entertainment electronics recycling, paper shredding, Styrofoam recycling, old paint recycling (at a cost), and Green Drop charity drop-off for City residents and City businesses. Official IDs with a City address must be presented to enter the drop off site.

We will also provide extra Yard Debris collections on Mondays in May in addition to regular Wednesday yard debris collections. Yard debris pickups are FREE! But residents must still call, email, or submit an online request for yard debris pickups. Public Works will also host its **Summer Construction Debris Drop Off** event for residential construction material at their facility on Saturday, June 22, 2024, from 9:00am to 2:00pm for City residents only. Once again, official IDs with a City address must be presented to enter the drop off site. No Commercial debris will be accepted! 




## Laurel Department of Community Resources and Emergency Management: Heat Your Home Safely this Winter!

Winter can bring extremely cold temperatures resulting in harsh outdoor conditions. Staying indoors as much as possible can help reduce your exposure to such extreme conditions, but staying indoors can also have its own set of hazards. It is important when heating your home to do so safely. Improper or unsupervised heating equipment can quickly lead to fires, gas or carbon monoxide leaks, and smoke inhalation.

Use the following tips to help you and your family prepare:

- Using your stove or oven as a heating source is not safe and can lead to dangerous gas leaks.
- When using a space heater make sure to keep them away from flammable materials like curtains or blankets.
- Use fireplaces, wood stoves, or other combustion heaters **only** if they are properly ventilated.
- Do not leave children or pets unattended near a space heater.
- Avoid using extension cords to plug in your space heater.
- If your space heater electrical cord is damaged or produces sparks, do not use!
